The roof at Doña Ana Elementary School is warrantied; however, Dow Roofing Systems, the warranty carrier, has since gone out of business and refuses to honor the warranty. Superintendent Rounds also shared with the Board that the replacement of the roof will not go through a request for proposal process, and stated that LCPS intends to bring litigation against Dow Roofing Systems for a failed warranty.
